You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 4 years.

Objectives

The Sub-Fund's investment objective is to achieve a total return in its Reference Currency by actively managing a diversified portfolio investing in worldwide equities with special focus to medium size market capitalization companies.

Furthermore, the Sub-Fund may invest in UCITS/UCIs equity funds, including eligible Exchange Traded Funds (ETFs) which invest mainly in equity, with a maximum exposure of 30% of the Sub-Fund's net asset value.

The aforementioned investment strategy corresponds for the investors to a moderate investment risk.

For treasury purposes the Sub-Fund may also invest in liquid instruments according to the criteria of article 41(1) of the 2010 Law such as (but not limited to) money market instruments and money market funds and bank deposits.

The Sub-Fund may hold ancillary liquid assets limited to bank deposits at sight with a maximum of 20% of the net assets of the Sub-Fund in order to cover current or exceptional payments, or for the time necessary to reinvest in eligible assets provided under article 41(1) of the Law of 2010 or for a period of time strictly necessary in case of unfavorable market conditions. Ancillary liquid assets do not include bank deposits, money market instruments, money market funds and other instruments that meet the criteria of article 41(1) of the 2010 Law. For hedging and for investment purposes, the Sub-Fund may use financial derivative instruments products traded on a regulated market and/or over the counter (OTC), provided they are contracted with first class financial institutions specialized in this type of transactions.

Intended retail investor

Reserved for retail investors and denominated in Euro. Minimum initial Investment: EUR 10,000.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 4 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 31/12/2021 and 31/12/2022 (If you exit after 1 year), 31/08/2021 and 24/09/2024 (If you exit after 4 years).

Moderate scenario: This type of scenario occurred for an investment between 24/04/2019 and 28/04/2020 (If you exit after 1 year), 30/03/2016 and 31/03/2020 (If you exit after 4 years).

Favourable scenario: This type of scenario occurred for an investment between 31/03/2020 and 30/03/2021 (If you exit after 1 year), 30/08/2017 and 31/08/2021 (If you exit after 4 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

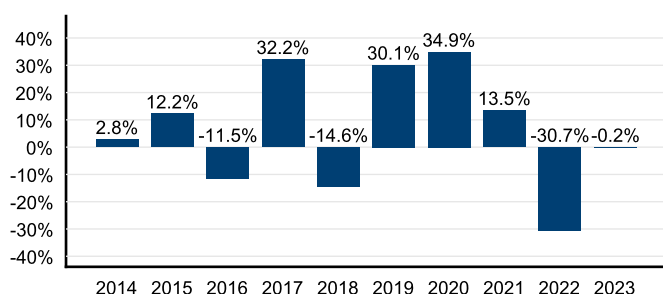
