You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-Fund is part of PEGASO CAPITAL SICAV, is a Luxembourg Investment Company (société d'investissement à capital variable) that has been established for an unlimited period in the form of an umbrella fund (the "Investment Company" or "Fund") with one or more sub-funds in accordance with Part I of the Luxembourg Law of 17 December 2010 relating to undertakings for collective investment, as amended. The Depositary is QUINTET PRIVATE BANK (EUROPE) S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

The investment objective of the Sub-Fund is to achieve medium-term capital growth through a flexible fixed income asset allocation based on the trends and opportunities offered by the financial markets. The sub-fund is actively managed, without reference to a benchmark.

The Sub-Fund may also invest directly and indirectly up to 100% in fixed income securities, including but not limited to fixed or floating rate securities, zero-coupon bonds, corporate bonds and treasury bonds, convertible bonds (up to 15% of the total net assets), high yield bonds (bonds with credit ratings below BBB- but above CCC+, up to 50% of the total net assets), unrated bonds (up to 15% of the total net assets) and as well as to CoCos (with a maximum exposure of 25% of the total net assets).

Non-performing and defaulted bonds (from CCC+ or equivalent to D or equivalent) are permitted up to a maximum of 5% of the total net assets. For bonds with more than one rating, the highest rating is taken into account. In the case of unrated issues, the rating of the issue is equated with that of the issuer.

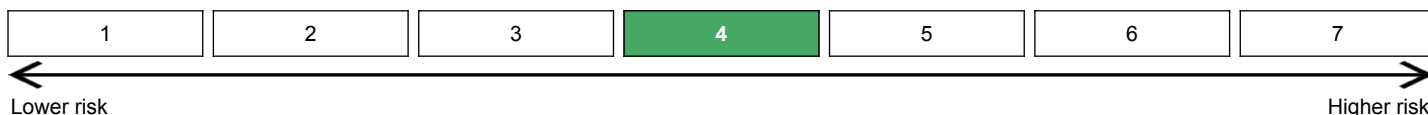
The aggregate high yield, unrated, cocos, and defaulted bonds is set at maximum 50% of the Sub-Fund's total net assets.

Intended retail investor

The Sub-Fund is suitable for growth-oriented shareholders. Due to the composition of the net sub-fund assets, there is a high degree of overall risk, but also a high degree of profit potential. Minimum initial investment EUR 1,000.00, however The Management Company is authorised to accept lower amounts at its discretion

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

You may not be able to sell end your product easily or you may have to sell end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Unfavourable scenario: This type of scenario occurred for an investment between September 2021 and September 2022 (If you exit after 1 year), September 2019 and September 2022 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between April 2016 and April 2017 (If you exit after 1 year), August 2017 and August 2020 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between October 2023 and October 2024 (If you exit after 1 year), June 2022 and June 2025 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

What are the costs?

Costs over Time

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

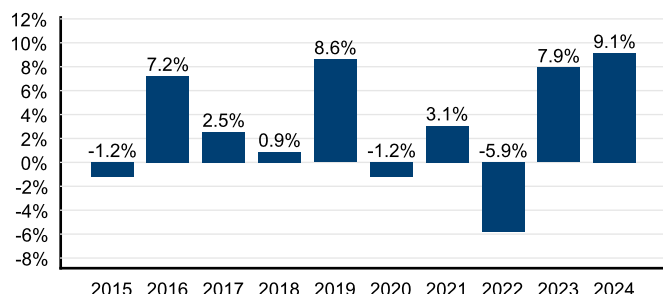
