You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of ABERSAND CAPITAL SICAV fund. The Fund is a Luxembourg open-ended investment company established as a société d'investissement à capital variable (investment company with variable capital) formed as a société anonyme (public limited company). The Depositary is UBS Europe SE.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

The investment objective of the Sub-Fund is to achieve long-term capital appreciation by investing in equities. To achieve this objective, the Sub-Fund will be managed combining a strategic and tactical asset allocation revised monthly based on proprietary models, which include fundamentals analysis and macroeconomics environment indicators. The Sub-Fund may achieve its investment objective directly by investing in listed equities or indirectly, by investing through UCIs/UCITS, including eligible ETFs (where the total allocation in UCIs should not exceed 30% of the Sub-Fund total net assets), money market instruments issued or dealt on the Eurozone and other international regulated markets and deposits.

The Sub-Fund may also invest up to 25% of its net assets in certificates of shares including certificates on stock indices. On an ancillary basis, the Sub-Fund may also invest investment grade bonds and in fixed income UCIs or UCITSs.

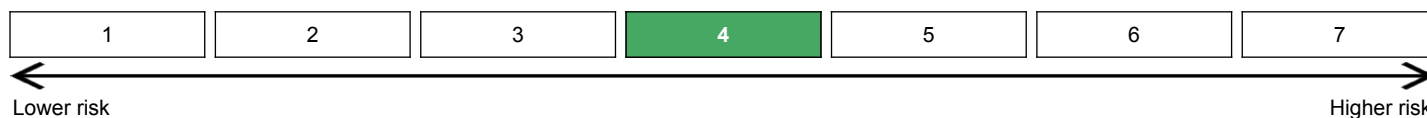
According to the Investment Policy, as investing mainly in equities, the Sub-Fund may assume more risk in order to obtain higher returns. As a consequence, the Net Asset Value can be subject to a high volatility with no capital guarantee. Such investment corresponds to investors with a high investment risk profile. The Sub-Fund employs the commitment approach as the global exposure determination methodology.

Intended retail investor

Reserved for retail investors denominated in USD. The investment strategy corresponds for the investors with a high investment risk profile. Minimum Initial Investment: USD 25.000.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 30/09/2021 and 30/09/2022 (If you exit after 1 year), 30/04/2021 and 30/04/2024 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 31/10/2022 and 31/10/2023 (If you exit after 1 year), 30/09/2016 and 30/09/2019 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 31/03/2020 and 31/03/2021 (If you exit after 1 year), 31/12/2018 and 31/12/2021 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

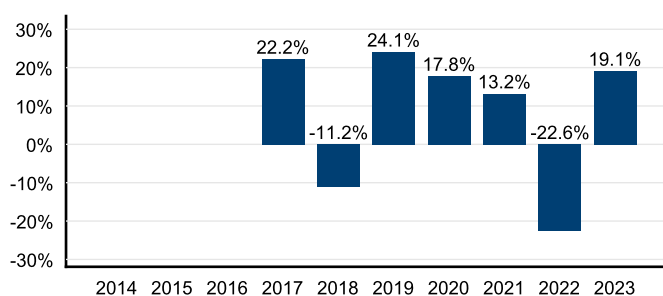
