## What is this product?

### Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

### Term

The investment horizon is medium term and should be at least 3 years.

### Objectives

The Sub-Fund is actively managed. The objective of the Sub-Fund is to gain exposure to global equity and fixed income markets by mainly investing through UCITS/UCIs including ETFs, with an opportunistic investment approach. The investment selection is based on quantitative criteria as performance and its risk indicators as well as qualitative ones as the constancy of the Investment Manager.

Depending on market conditions, investments may be focused on one asset class and/or on one geographical area and/or one sector of economic activity and/or one currency only. The allocation per each underlying UCITS/UCIs will be made in order to maximize the profitability/risk ratio of the Sub-Fund and generate capital appreciation over time with no particular restrictions. It is intended to leave to the Investment Manager the needed flexibility in order to take advantage of the opportunities the markets offer.

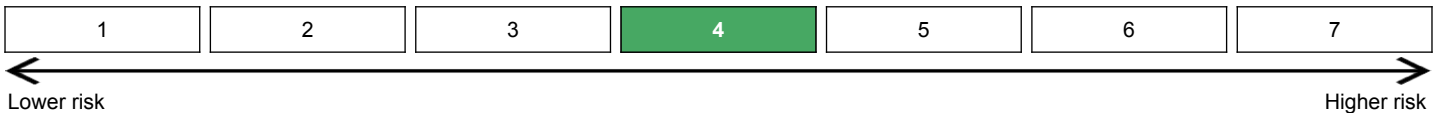
On an ancillary basis, the Sub-Fund may invest directly in equities, bonds (including but not limited to convertible bonds, high yield bonds with a maximum exposure of 10% of the Sub-Fund total net assets, fixed-rate or floating securities, zero-coupon bonds and treasury bonds) and in high yield bond funds with a maximum of 15% fund. The Sub-Fund may also invest in money market instruments issued or dealt on the Eurozone and other international regulated markets and deposits.

### Intended retail investor

Reserved for retail and institutional investors denominated in EUR. The investment strategy corresponds for the investors with a medium to high investment risk profile. Minimum Initial Investment: EUR 1,000.

## What are the risks and what could I get in return?

### Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Unfavourable scenario: This type of scenario occurred for an investment between 27/03/2019 and 25/03/2020 (If you exit after 1 year), 29/03/2017 and 25/03/2020 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 28/11/2018 and 27/11/2019 (If you exit after 1 year), 27/05/2015 and 31/05/2018 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 25/03/2020 and 31/03/2021 (If you exit after 1 year), 25/03/2020 and 29/03/2023 (If you exit after 3 years).

## What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

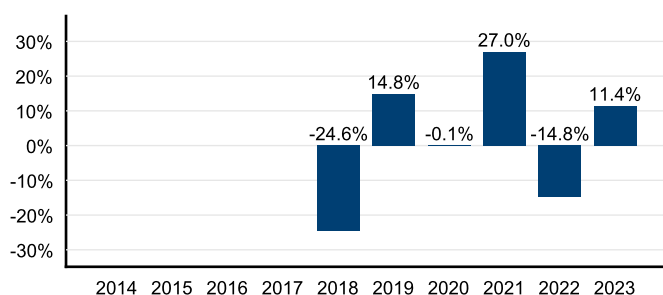
