You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of A&G FLOTA fund. The Fund is organized in and under the laws of the Grand Duchy of Luxembourg as a mutual investment fund ("fonds commun de placement"). This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

The Investment Objective of the Sub-Fund is to achieve mid-term capital appreciation. The Sub-Fund seeks to accomplish this objective through investing primarily – directly or indirectly through UCIs/UCITS including ETFs - in equity and fixed income mainly issued in OECD countries. The Sub-Fund is managed following a geographical as well as sectorial diversification, based on combination of global and value-based selection approach with a multi-asset allocation strategy, unrelated to benchmark constraints.

The Sub-Fund is invested – directly or indirectly through UCIs/UCITS including ETFs - in equities and in bonds including but not limited to: convertible bonds, fixed-rate or floating securities, zero-coupon bonds and treasury bonds). The Sub-Fund is invested also in:

- High yield bond with maximum exposure of: 50% of the Sub-Fund total net assets,
- Non-rated bonds with maximum exposure of: 10% of the Sub-Fund total net assets
- CoCo bonds with maximum exposure of: 20% of the Sub-Fund total net assets (in aggregate maximum exposure of high yield bond, non-rated bonds and CoCo bonds, limit of 50%, of the Sub-Fund total net assets).

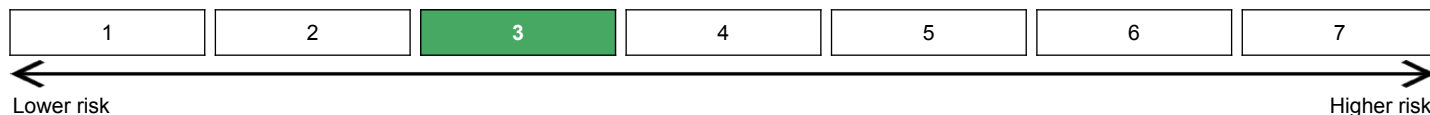
The Sub-Fund may also invest up to 10% of the net asset value, through exchange traded notes ("ETN") or exchange traded commodities ("ETC") in accordance with the 2010 UCITS law and the Grand-Ducal Regulation of 8 February 2008.

Intended retail investor

Reserved for retail and institutional investors denominated in EUR. The investment strategy corresponds for the investors with a high investment risk profile.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 29/10/2019 and 27/10/2020 (If you exit after 1 year), 25/09/2018 and 26/09/2023 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 28/02/2023 and 27/02/2024 (If you exit after 1 year), 29/12/2015 and 31/12/2020 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 23/02/2016 and 28/02/2017 (If you exit after 1 year), 28/10/2014 and 29/10/2019 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

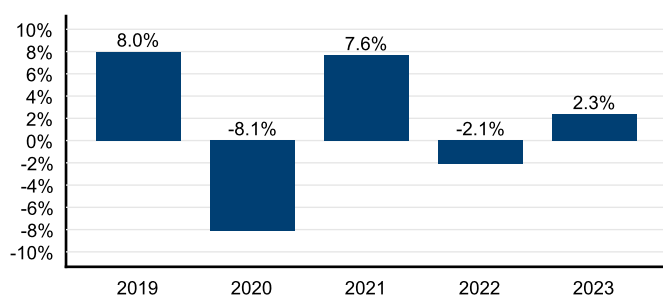
