You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

The Sub-Fund is actively managed. The Investment Objective of the Sub-Fund is to achieve a total return via indirect investment in interest rates and capital appreciation across the business cycle, understood as a time frame of 3-7 years. The Sub-Fund seeks to accomplish this objective through investing primarily in UCIs/UCITS, including eligible EU Exchange Traded Funds (EU ETFs), which invest in fixed income instruments across the full risk spectrum from government backed bonds to riskier high yield bonds without any rating restrictions. The Sub-Fund via UCIs/UCITS, will invest primarily in fixed income instruments from issuers from OECD countries, but also intends to hold emerging market bonds (with a maximum exposure of 30% of the Sub-Fund total net assets). Additionally, the Sub-Fund will from time to time consider investing in equities via UCIs/UCITS, but not on a permanent basis and not more than maximum 10%.

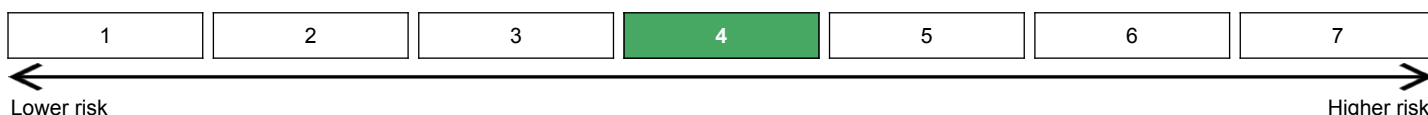
Depending on market conditions, the portfolio of UCIs/UCITS in the Sub-Fund will be changing both in term of credit rating, issuer background, geographical exposure, and duration. Specifically, the Sub-Fund will seek to increase expected return by increasing the indirect exposure to risky credits like high yield bonds and emerging market bonds when the outlook for financial markets is expected to improve and or when the outlook is showing improvements. When the environment and outlook is deteriorating the Sub-Fund will focus on UCIs/UCITS consisting solely or primarily in investment grade fixed income instruments.

Intended retail investor

Reserved for retail investors denominated in USD. The investment strategy corresponds to investors with a medium investment risk profile. The Sub-Fund will be targeting an annualized average volatility of 4-6% across the business cycle and on a 5-year rolling basis.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Unfavourable scenario: This type of scenario occurred for an investment between 31/12/2021 and 31/12/2022 (If you exit after 1 year), 28/09/2018 and 29/09/2023 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 30/11/2015 and 30/11/2016 (If you exit after 1 year), 31/03/2017 and 31/03/2022 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 31/01/2017 and 31/01/2018 (If you exit after 1 year), 29/02/2016 and 26/02/2021 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

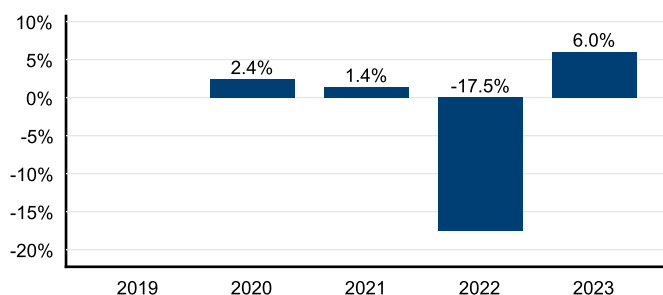
