You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

The Sub-Fund is actively managed without any reference or constraints relative to a benchmark or index.

The investment objective of the Sub-Fund is to generate positive average annual returns from liquid global fixed income markets, mainly via the corporate bond universe segment.

The strategy employs a combination of investment approaches across mainly EUR, USD and GBP denominated Investment Grade and High Yield universes to provide investors with a global and active fixed income solution for all market environments. The strategy seeks to enhance returns on a risk-adjusted basis by using directional, relative-value and thematic investing techniques to express the portfolio managers views across the universe landscape. There is no concentration on any particular theme.

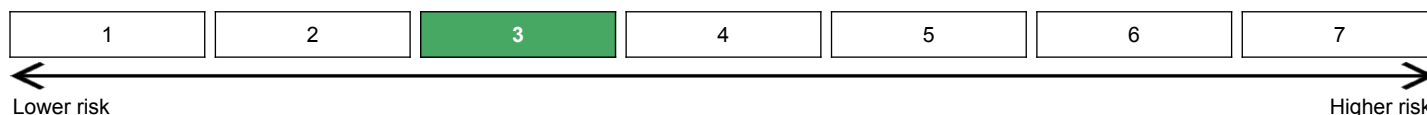
The Sub-Fund seeks to accomplish this objective through investing primarily in bonds from issuers from OECD countries, but also in emerging markets (with a maximum exposure of 15% of the Sub-Fund total net assets). No investments in Russia or China are targeted.

Intended retail investor

Reserved for retail investors denominated in EUR. The investment strategy corresponds for the investors with a medium investment risk profile. Minimum Initial Investment: EUR 10,000.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 30/09/2021 and 30/09/2022 (If you exit after 1 year), 30/10/2020 and 31/10/2023 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 30/06/2020 and 30/06/2021 (If you exit after 1 year), 31/07/2015 and 31/07/2018 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 29/09/2023 and 30/09/2024 (If you exit after 1 year), 29/12/2017 and 31/12/2020 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

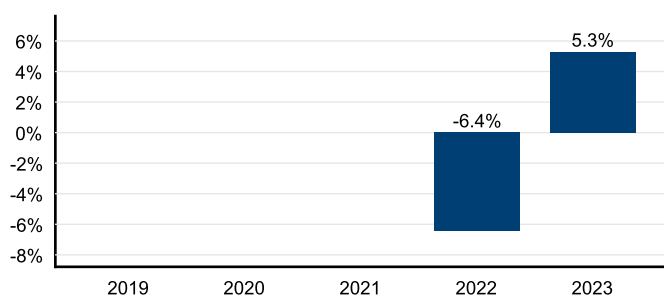
