You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of A&G FLOTA fund. The Fund is organized in and under the laws of the Grand Duchy of Luxembourg as a mutual investment fund ("fonds commun de placement"). This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

The Investment Objective of the Sub-Fund is to achieve mid-term capital appreciation. The Sub-Fund seeks to achieve sustained returns over time, applying an investment philosophy based on the fundamental analysis.

The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio, subject to the stated investment objectives and policy.

The Sub-Fund will be invested up to 100% of its net assets in listed equities and securities of any sector or market capitalization. The Sub-Fund may also invest up to 50% of its total net assets in Fixed Income assets (including but not limited to: fixed-rate or floating securities, zero-coupon bonds and sovereign/government bonds). High yield bonds (incl. non-rated bonds) will be limited to maximum exposure of 15% of the sub-fund total net assets. However the exposure to high-yield bonds rated CCC+/Caa1 (distressed) and below will be limited to 5% of the Sub-Funds total net assets. The maximum exposure of high yield bond and non-rated bonds is limited to 15% of the sub-fund total net assets and the maximum exposure of CoCo bonds is limited to 10% of the sub-fund total net assets.

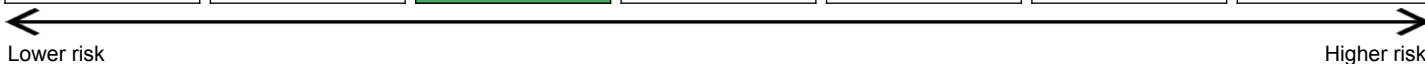
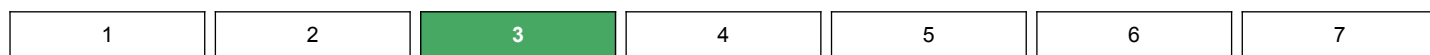
Geographical focus will be OECD countries. The Sub-fund may invest in any sector and in any market, including emerging markets up to 40% of the net assets. The maximum exposure to China is limited to 10%, there will be no domestic exposure to China.

Intended retail investor

Reserved for retail and institutional investors denominated in EUR. The investment strategy corresponds for the investors with a high investment risk profile.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 31/12/2021 and 31/12/2022 (If you exit after 1 year), 31/12/2019 and 31/12/2022 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 30/11/2016 and 30/11/2017 (If you exit after 1 year), 31/05/2017 and 29/05/2020 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 31/03/2023 and 28/03/2024 (If you exit after 1 year), 31/12/2018 and 31/12/2021 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

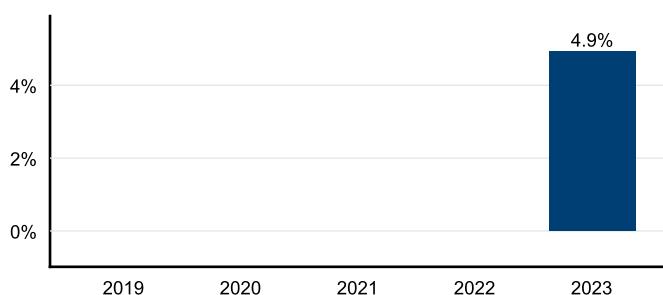
