You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of BA³ STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

The Sub-fund is actively managed. The investment objective is to achieve medium term capital increase by applying different investment strategies within a wide range of asset classes, in line with the risk budget. The allocation will be made from time to time in an opportunistic manner; for this reason the investment focus may change in the short term.

The Sub-Fund can invest with a global approach in different asset types, either directly and/or indirectly through UCI/UCITS including ETFs, such as listed equities and bonds (including but not limited to convertible bonds, high yield bonds, fixed-rate or floating securities, zero-coupon bonds and treasury bonds), money market instruments and deposits.

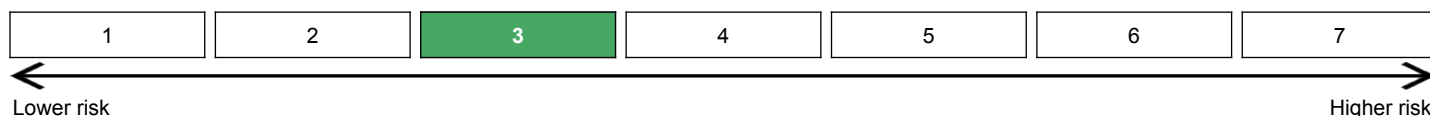
Financial instruments will be mainly denominated in EUR or in currencies of OECD countries. No more than 30% of the value of the Sub-Fund may be invested in financial instruments denominated in non-OECD currencies.

Intended retail investor

Reserved to retail and institutional investors. This Sub-Fund is addressed to investors who seek capital growth in the medium term with a conservative multi-asset allocation, with the purpose to maintain the Value At Risk (VaR) of the portfolio within the 5% level, with VaR being calculated using the historical simulation model, over a reference horizon of one month and a 99% confidence interval, using time series with a depth of 500 daily data points. Minimum Subscription: 1.000 EUR.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 31/12/2021 and 31/12/2022 (If you exit after 1 year), 30/11/2020 and 30/11/2023 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 31/12/2014 and 31/12/2015 (If you exit after 1 year), 31/03/2016 and 29/03/2019 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 31/03/2020 and 31/03/2021 (If you exit after 1 year), 31/12/2018 and 31/12/2021 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

The investments of the fund are held separately from the assets of Adepa Asset Management S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of Adepa Asset Management S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Recommended holding period: 3 years
